It is the policy of the Quincy Volunteer Fire Department that all new volunteer firefighters meet certain minimum training standards prior to participating in emergency incidents. Training requirements may be met in the following ways:

1. Complete and pass the 40-hour volunteer training course offered by the Quincy Fire Department.
2. Complete and pass a volunteer Firefighter-1 Academy through the state.
3. Documentation of previous experience and/or training in structural firefighting within the past two years. Acceptance of this training is at the discretion of the Membership Committee
